Environmental Science Project

*"Water Quality Monitoring on the Yellowstone and Musselshell Rivers —
Using Species of Concern to Assess Water Quality Contaminant Loads"*

Montana Fish, Wildlife and Parks has listed soft-shell and snapping turtles as Tier 1 Level S3 Species of Concern and a number of studies have shown a correlation in their decline due to heavy metal contaminants. This undergraduate student research project intends to establish baseline of heavy metal contaminant levels in the Musselshell and Yellowstone Rivers and in soft-shell and snapping turtles. *"Distribution of Carnivores in the Absaroka-Beartooth Wilderness Area —
Engaging Citizen Scientists"*

This project will study common and elusive carnivores of the Absaroka-Beartooth Wilderness by increasing public involvement in conservation through participatory science. Citizen scientists will use camera-trapping stations to collect data that will improve research, and promote environmental education and action. Vital Ground will own the property long-term and manage it under a Community Forest Plan advised by a volunteer stakeholder committee comprised of project partners, forest management professionals, educators, and interested members of the local community.
