2021 + 2022 Conservation Partners

In 2021, Cinnabar awarded 66 grants and five awards totaling \$427,000. Our grantees impressively leveraged their grants, on average, more than three times over, resulting in more than \$1.3 million of new funding directly supporting conservation in Montana and the GYE. Read more [here](#).

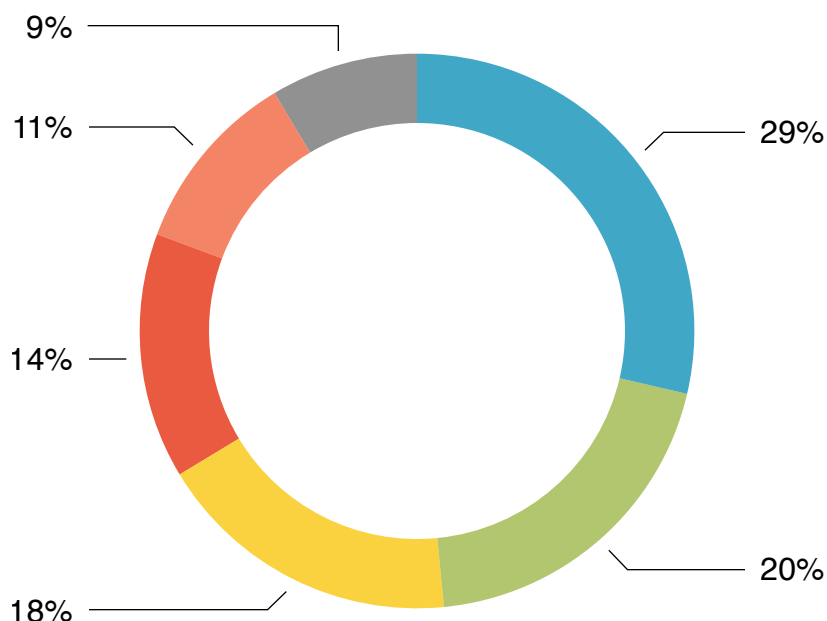
